APPLICATION FOR CONDITIONALLY EXEMPT SMALL QUANTITY GENERATORS (CESQG)

To use Tompkins County's Household Hazardous Waste Management Facility (DEPOT)

**Please read first:** State and federal laws exempt some commercial hazardous waste generators from strict waste management regulations, based on the amount of hazardous waste generated and stored. To be considered a conditionally exempt small quantity generator (CESQG), you must:

 Produce less than 220 pounds or 28 gallons (100 kilograms) – approximately ½ of a 55-gallon drum of hazardous waste (“hazwaste”) in any given month; or no more than and about 2.2 pounds or 1 kilogram, of acutely hazardous waste in any calendar month.

 You must also never accumulate more than 2,200 pounds (1,000 kilograms) – approximately 5 drums of hazwaste on your property.

 For assistance in determining your eligibility as an exempt generator, please call either the New York State Department of Environmental Conservation at 800-452-1925 or the Tompkins County Solid Waste Management Division (TCSWMD) at 273-6632.
